Important information about your Pre-Wedding Prep and Trial:

- ◆ Bridal hair and makeup services include a trial run, so we can be sure to perfect your look before the big day. We prefer a wedding style trial to be scheduled 2 to 3 weeks prior to your wedding day. When you arrive for your trial, please have dry hair and bring any hair accessories (flowers, veil, hair extensions, etc.) that you plan to use on your wedding day.
- ◆ We schedule sufficient time at the trial to discuss options with you, but find it works best when the bride already has a clear understanding of what the overall “look” will be. Pictures are always helpful!
- ◆ We highly recommend a series of Customized Aveda Facials beginning 6 months prior to your wedding. This will ensure a beautiful complexion and the perfect canvas for your makeup. Check out our facial series of buy three facials get one free. And drink lots of water!
- ◆ It would be best to begin anybody waxing 3 months beforehand. We can take care of everything from brows to full Brazilian waxes. With each appointment the process will be less painful. Your last appointment should be about 2 days before the “Big Day”
- ◆ Eyelash extensions are a fabulous way to enhance your eyes and will replace the need for mascara (there may be tears of joy – but no running mascara). Lashes are life changing in so many ways. Check out our lash page or feel free to call and ask our lash professional about the timing and requirements for these beautiful little whispers of wonderment.
- ◆ Manicure and Pedicure services should be booked the day before your ceremony.
- ◆ Your stylist should tailor your hair needs and map out a plan of action for color, cuts or conditioning treatments months in advance. Please take a look at our Team page, if you are not already in good hands.
